



Samantha Abela Violin Booking Agreement

Thanks for your interest in booking Samantha for your event! We can't wait to work with you. Before booking Samantha, please read through the requirements below. If you have any questions at all, please feel free to reach out.

1. DEPOSIT & FINAL TOTAL

A \$500 non-refundable booking fee is to be paid to secure your event date. The deposit amount will be deducted from the final total.

The remaining total is to be paid 7 days prior to the event.

2. CANCELLATION POLICY

If a client/agent cancels the event and/or performer, the following fees will apply:

- *3 months prior to event - 30% of remaining fee to be paid*
- *2 months prior to event - 50% of remaining fee to be paid*
- *1 month prior to event - 75% of remaining fee to be paid*
- *2 weeks or less prior to event - 100% of remaining fee to be paid*

3. PERFORMER SICKNESS/UNABLE TO PERFORM

If a performer is unable to make the event due to circumstances outside of control the following will apply:

A suitable* cover must be provided.

If a cover is unable to be provided or Samantha terminates the booking, a full deposit is to be refunded to the client.

*suitable cover: an equivalent musician in a similar field.

4. RESCHEDULING DUE TO COVID-19

Deposit will be credited for the new event date if reschedule date is within 12 months of original date.

A minimum of 3 date options must be supplied to allow the best opportunity to reschedule. If no date can be found, Samantha will terminate the booking and refund 80% of the deposit.

Original agreed fee will remain the same if within 12 months.

If rescheduled date exceeds 12 months from original date, this is regarded as a cancellation and deposit will not be refunded if event or entertainment is canceled, deposit will not be refunded.

5. VENUE & RUNSHEET

Venue and event/wedding planner details are to be provided once deposit has been paid.

Run sheet is to be provided 7 days prior to the event date.

6. BAND MEALS & GREEN ROOM

1 x brand meal is to be provided per band member for bookings of three hours or above.

Access to soft drinks, beer, wine and champagne.

Green room and/or band table must be provided for bookings of three hours or above.

7. ACCOMODATION

Where accommodation is required - hotel or AirBnb no more than 15 minutes from the venue.

This can either be booked by the client, or we can book it and add it to the final invoice notice.

8. FLIGHTS

Virgin Australia, Economy X

9. TRANSFERS

Transfers on the ground will be estimated as part of a quotation.

Car hire: either a compact or SUV depending on equipment needed.

Please note: if in the result any of the above requirements are not met, Samantha reserves the rights to terminate the booking.
